Shortlisting of eligible contractors/suppliers will be done based on the following criteria: experience of the contractor/supplier, qualification of personnel and current workload. Only eligible bidders shall make up the shortlist.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation IRR



The Eligibility Screening Form will be available at the BAC Secretariat, upon payment of a non-refundable amount of P500.00.

The Municipality of Pulilan assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid. Bids must be accompanied by a bidder's bond, either in cash, manager's check or surety bond in the amount equivalent to 2.5% of the total amount of bid.

The right is reserved for the Municipality to reject any or all bids, to waive any defects therein, and to accept such bids as may be considered most advantageous to the government.
