Shortlisting of eligible contractors/suppliers will be done based on the following criteria: experience of the contractor/supplier, qualification of personnel and current workload. Only eligible bidders shall make up the shortlist.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).

Bids must be accompanied by a bidder's bond, either in cash, manager's check or surety bond in the amount equivalent to 2.5% of the total amount of bid.
