AN ORDINANCE TRANSFERRING SOME PLANTILLA POSITIONS FROM THE OFFICE OF THE MUNICIPAL MAYOR TO THE MUNICIPAL TOURISM OFFICE OF THE MUNICIPAL GOVERNMENT OF PULILAN, BULACAN

WHEREAS, Section 76 of Republic Act No. 7169, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 (a)(1)(viii) of the same Code states that the sangguniang bayan, as the legislative body of the municipality, shall enact ordinances that will determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees of the municipal government;

WHEREAS, the Municipal Government of Pulilan have continuously adjust to rapid change since local government units will now assume more complex roles in socio-economic development and will continue to help shape the developmental directions of our country;

WHEREAS, innovations and reforms are needed to make our municipality more relevant, accountable, responsive and proficient that will meet the priority needs and to cope with the developmental plan, programs and objectives of the present administration;

Section 1. The positions enumerated below are hereby transferred:

From: Office of the Municipal Mayor
 To: Municipal Tourism Office

Tourism Operations Officer I	SG 11	1-17	20-1
Tourism Operations Officer II	SG 15	1-30	20-2

Section 2. The employment of officers/employees affected by the aforementioned transfer of plantilla positions in the Municipal Government of Pulilan shall be deemed transferred to said office without reduction of salaries and other benefits and without loss of rank including the plantilla positions they occupy.

Section 3. The corresponding salaries and other benefits of positions mentioned in Section 1 shall be appropriated in their new office assignment which is incorporated in the General Fund Annual Budget for Fiscal Year 2023.

Section 4. This Ordinance shall take effect upon its approval.
